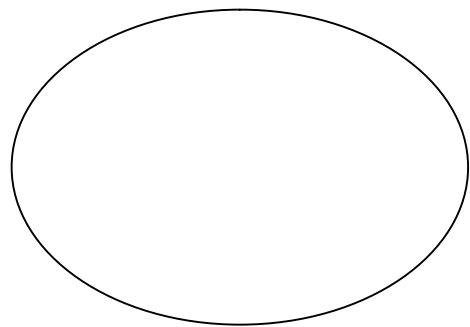

Rules, Regulation, Law, Terms & Conditions of the Association

- **The Person should be an Indian by nationality.**
- **The Person should be 18 years old to join the Organization.**
- **The documents which will be submitted to the organization should be in photo copy & self attested.**
- **The documents which will be submitted to the organization are (Voter Id /Adhar Card /Education Qualification/Pan card/Age proof/Bank account).**
- **Two passport size photos with self attested.**
- **The Person who wants to be a member of the organization will pay Rs fifty only (50/-) which will be non refundable in any casa & it's the processing fees.**
- **The monthly subscription of the Organization will be Rs One Hundred only (100/-) and should deposit with in 1st week of the month.**
- **The member will be selected to the Organization after being proposed and seconded by the existing members with the consent of at least 2/3rd (two - third) of the member of the Executive Committee of the Organization.**
- **The Executive Committee of the Organization shall have the right to disqualify or to remove the Person from membership who has been found guilty.**
- **The person shall not be eligible for the selection / election as a member of the Executive Committee, if he/she has been a member of the Organization for less than 1 year.**
- **Once in a month, one general meeting of the Organization shall be held, in that meeting all members should remain present.**
- **The Governing Body shall have the power to increase, decrease or vary the amount of monthly/annual subscription from time to time. Additional subscription, in addition to the monthly/annual subscription referred to hereinabove, may be collected by the Governing Body from Members for a general or specific purpose or project.**
